SUBLINGUAL SEMAGLUTIDE PROTOCOL

Initial dispensing

- o Strength: 3mg/ml
- o 15ml bottle = 12-week supply
- o Sig:
 - 0.15ml 3 times a week x 2 weeks
 - 0.3ml 3 times a week x 2 weeks
 - o.5ml 3 times a week x 8 weeks

Ongoing dispensing

- o Strength: 3mg/ml
- o 18ml bottle = 12-week supply
- o Sig: 0.5ml 3 times a week
- o If not achieving desired weight loss, may increase frequency up to daily dosing
- If transitioning from injection (at the full dose), daily dosing recommended, pharmacists available for consultation on individual patient cases

Key patient counseling points

- Brush teeth, floss, rinse mouth with warm water before administering
- Shake the bottle for 20-30 seconds.
- Swish and hold the suspension under tongue and around checks for at least 90 seconds.
- Hold dose if no bowel movement in last 3 days

WHY PRESCRIBE COMPOUNDED SUBLINGUAL SEMAGLUTIDE?

- Some patients prefer sublingual delivery to injections.
- In 2024, a novel suspension base (Submagna™ Suspension) was developed to effectively deliver large molecule drugs, such as semaglutide, under the tongue.

Permeation studies with Submagna HMW show efficient delivery of semaglutide through mucosal tissue.




Image 5. Permeation flux of the sublingual semaglutide compounded formulation over time for 30 minutes.




Image 6. Permeation flux of the sublingual semaglutide compounded formulation over time for 30 minutes.
